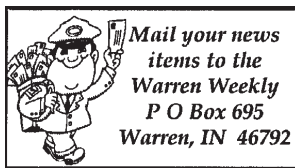

NEW POLICY FOR WEST NILE TESTING

The State Department of Health has stopped testing dead birds from counties that have already had at least one positive test re-

sult confirmed this year for West Nile virus.

State health officials say this new policy is the result of the heavy demand for West Nile virus testing within Indiana. The purpose of the policy is to make the best use of laboratory resources while continuing to provide essential epidemiological information on the distribution and spread of West Nile virus in Indiana.

The policy, which was sent to local health departments on Friday, says: 1) Birds should not be submitted from counties where at least one test (human, horse, bird, or mosquito) has been confirmed positive for West Nile virus. 2) Samples already received from those counties where a positive test has been found will not be tested. 3) Bird samples from those counties where no positive tests have been found will continue to be accepted and tested until a positive has been found. 4) The State Laboratories will continue to test mosquitoes submitted from all counties.

AREA NEWS

"OUR TOWN"

Minutes of "Our Town Committee" Meeting, August 13, 2002 - Since new members and future business owners, Gerald and Jennie Overby were in attendance, the meeting began with roundtable introductions. Minutes of the previous meeting were then reviewed and recommended for approval with the amendment that Harold Jones is NOT the chair of the Arts Festival. That position is yet to be filled.

The Finance Committee reported that it is still waiting to hear whether Warren will receive a grant to beautify our downtown.

The Programs Committee reported that the Warren Arts Festival will be held on May 17, 2003 and will last one day. Various subcommittees and their chairs include: 1) Arts Market - Co-chairs Bob and Nancy Smyth and Brady Smekens; 2) Drama Performance - Cynthia Wartzok-Smyth; 3) Hands-on Visitor Art - Co-chairs Bridget Swaidner and Anita Sharp; 4) Food - Marilyn Morrison; 5) Finance Committee - Kevin DeaKyne; 6) Publicity - Christina Smekens; 7) Logistics - Ned Trout; and, 8) Student Art Displays - Bill Cartwright. Chairman positions are still available for the Vocal and Instrumental Performing Arts, High-School Jazz Competition, Contests and Clinics, and Dance Studio. If you are interested in claiming responsibility for one of these events, please call Kimberley Fuller (375-4949).

The Auditing Committee distributed copies of the most current edition of the Our Town Committee By-Laws. Mr. Bill Cartwright noted that the revised by-laws include 21 membership positions including 6-10 at large seats and 4 business owner representatives. It was decided that members are inactive if they miss 3 consecutive meetings. Mr. Cartwright also brought to the committee's attention the difference between officers and executive board members. Understanding that these by-laws are a work in process, Mr. Cartwright moved to have them adopted as our official guidelines and Harold Jones seconded the motion. They will now be submitted to the town attorney for approval of the committee's tax-free status.

The PR Committee made a spe-

cial note of thanks to Sara Lance for stuffing over 1,000 "Warren" pamphlets into pharmacy bags that were distributed to local businesses for patrons to read.

At the conclusion of committee reports, we heard a presentation from Mr. Terri Daniels, owner of Warren Pharmacy, concerning committee support to local businesses. Mr. Daniels expressed frustration that the Ball State study done earlier this year was not more helpful in terms of suggesting period-appropriate interior design and façade improvements. The committee understands Mr. Daniels concerns and suggested that if the town receives a T21 grant, a façade study will likely be done to help local business visualize possible improvements. Mr. Harold Jones suggested that the Huntington County Historical Society might also be a helpful resource for business owners to get color schemes and pictures of what local establishments might have looked like over history.

We would like to invite Warren residents and visitors to share photographs of the downtown center and businesses that have existed here during the past 100 years. Please contact Kimberley Fuller (375-4949) for assistance.

Mr. Daniels would also like to know if anyone knows of an organization that could provide connections for non-drug wholesale items such as shoelaces, wrapping paper and ladies stockings, for example. If you have any ideas, please contact Kimberley Fuller (375-4949) and she will pass the information to Mr. Daniels.

Local businesses should also note that the committee is offering to donate our it's members' physical labor to help merchants paint or repair business locations.

WINDOWS COMPUTER TIPS

Find Your Way Back to a Web Page You Saw Some Time Ago

To find a page that you visited days, weeks, or even months ago, but which you never added to your Favorites, you can use the History list in Internet Explorer 6 in

Windows XP to help track it down. Click the History button on the toolbar. The History bar appears, containing shortcuts to every page you've been to today, yesterday, the day before, and so on for the previous three weeks. The links are organized by week. To find the link you want, click the week that you believe you saw it. Links in each week's groupings are listed alphabetically.

Note: You can change the number of days that pages are saved in the History list (click Tools, then click Internet Option, and then look for the History section of the General tab). The more days you specify, the more disk space is used on your computer to save that information.

Huntington County veterans who have passed away this year are remembered on a new page on the Veterans' Office website. Family members of veterans who pass away in 2002 will be able to see the pages as they are building by accessing the website at www.huntington.in.us/county/veterans/2002remembrances.html.

Veterans' Officer Tom Applegate said Monday that he has long been bothered that he has been unable to bring new pages on line quick enough after the annual Memorial Day programs in May of each year. "I never seem to be able to get all the pages finished until some time in July or August, fully two or three months after the event is over. This year is a good example. I just announced on August 12th that the pages for Memorial Day 2002, which was on May 27th, were finished."

Applegate hopes that will be the last time it takes so long. All of the pages for Memorial Day 2003 are already started, and each contains all the information on each veteran from the obituary and from any record of military service which has so far been received by

the Veterans' Office. "I have full information for some veterans," Applegate said. "For others, I only have the information which was contained in the obituary."

Each of the pages will eventually contain each veteran's name, rank and branch of service, the years they served and a brief summary of their time in the service and decorations and medals they were awarded. Additionally, each page will contain a brief summary of who the veteran married and how many children they had. Each page will also show graphic representations of the branch of service, rank, and medals and awards received by each veteran.

The pages will eventually be the same pages which will appear on the Memorial Day 2003 site after the program, except next year the site will be up and running very quickly since the pages will already be ready. The biggest difference is that survivors and friends will be able to watch the pages as they develop by logging in on the site.

NOMINATE HONOREES

TIPS ON PREPARING LATCH-KEY KIDS

Nightly news reports of child abductions as millions start school and spend afternoons "home alone" is cause for parents to be alert but not alarmed, says the Indiana Crime Prevention Coalition.

"Working parents - and that's the majority of American and Hoosier families today - are this year experiencing added anxiety, frustration and even fear involved with leaving children on their own after school," says Scott Minier. Executive Director of the Indiana Crime Prevention Coalition. "Sometimes well-laid childcare arrangements break down or there simply aren't alternatives to kids being 'home alone' between school and when parents get home from work."

Minier and the not-for-profit ICPC say the first thing to help reduce this back-to-school stress is to get organized: 1) Make sure your children are ready to care for themselves; 2) Teach them basic safety rules; and 3) Set ground rules requiring you know where

your kids are, what they are doing and whom they are with.

ARE THEY READY? CAN YOUR SON OR DAUGHTER...

- Be trusted to go straight home after school?
- Easily use the telephone, locks and kitchen appliances?
- Follow rules and instructions well?
- Handle unexpected situations without panicking?
- Stay alone without being afraid?
- HAVE YOU PREPARED YOUR 'HOME ALONE' CHILD...**
 - How to call 9-1-1 in case of emergency?
 - How to give directions to your home?
 - To check in with you or another trusted adult immediately after arriving home?
 - To never accept gifts or rides from people they don't know well?
 - How to use the door, window locks and the alarm system if you have one?
 - To never let anyone in your home without asking permission?
 - To never let a caller at the door or on the phone know they're alone?
 - To carry a house key with them in a safe place (inside a shirt pocket or sock) - not under a mat or on a ledge?
 - How to escape in case of fire?
 - To not go into your home if things don't look right (broken window, ripped screen or opened door)?
 - To let you know about anything that frightens them or makes them feel uncomfortable?
- A WORD ABOUT CURIOSITY...**
 - "Are there things you don't want your children into?" Minier asks.

"Take the time to talk to them about the deadly consequences of guns, medicines, power tools, alcohol and cleaning products. Make sure you keep these items in a secure place out of sight and locked up.

Finally, the best way to know for sure if your child is ready to be "home alone" is to talk it over with them, says Minier. "Listen to their worries and ideas. Work out rules on having friends over, accomplishing household chores, study-

ing homework and watching television. Remember, staying at home alone can be a positive thing for children. It can build a child's self-esteem, sense of responsibility and practical skills."

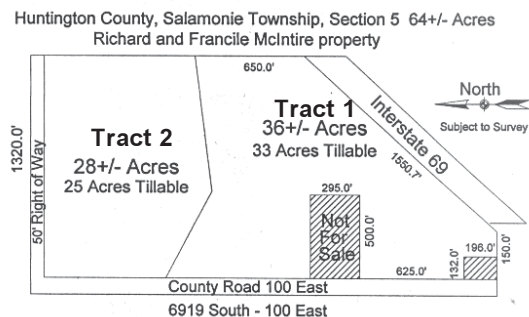

Then, find out how to stay safe and comfortable during your travels with Fly Smart from the Federal Aviation Administration and Travel Smart - Travel Safe from the U.S. Department of State.

Keep these tips in mind when you fly:

Most airlines overbook their flights to compensate for no-shows. If your flight remains overbooked, you may voluntarily give up your seat and negotiate with the airline representative to get a later flight and compensation such as another free flight later. Or upgrades to first class.

If you are involuntarily "bumped" from your flight and you had a confirmed reservation, meet the airline's ticketing and check-in deadlines, and your replacement flight arrives more than an hour after your scheduled flight, you could be eligible for monetary compensation, free flights, and more.
