



#### Dark Chocolate Chiffon Cake

5 Large Egg Whites, ¾ C Water, 3 Large Egg Yolks, 1 t. Vanilla, 1 T instant coffee powder, 1 pkg Devils Food Cake, ½ t Cream of Tartar, ½ C Vegetable Oil.

Beat egg whites and cream of tartar on high speed 2-3 minutes until stiff peaks form. Set bowl aside. Place sifted cake mix and other ingredients in a large bowl and beat on low 1 minute. Stop and scrape sides down and beat another 2 minutes on medium speed. Add in the beaten egg whites and fold into the cake batter until well blended. Put in tube pan and smooth top. Bake at 325 for 48-52 minutes. When done turn pan upside down on a bottle to cool. Remove from pan after

#### Chocolate Butter Frosting

1 stick butter room temperature, 2/3 C unsweetened Cocoa Powder, 1/3 C whole milk, 2 t Vanilla, 3 C confectioner's sugar (sifted plus more if needed), ¼ t salt.

Beat butter and cocoa until well combined, about 30 seconds. Add other ingredients and beat until frosting lightens and is fluffy. You can add more confectioner's sugar or milk if necessary.

## AREA NEWS CONTINUED

#### **TOWN MINUTES**

The Town Council of the Town of Warren met Monday, July 13, 2015 at Assembly Hall, Council Meeting Room, 131 N. Wayne Street, in accordance with rules of Council and applicable law.

Those present were: Town Council, Ethan Stivers, Julia Glessner, Steve Buzzard, Tracey Brown; Clerk-Treasurer, Marilyn Morrison; Employees, Lee Poulson, Dennis Spitler and others.

President Glessner called the meeting to order at 5:00 pm.

Minutes of Regular Meeting of June 8, Executive Session of June 26 and Special Session of June 26 were approved as submitted.

Introduced was a Scout attending for credit as he works toward his Eagle Scout level.

Marla Stambazze, Department of Community Development, reviewed status of properties under orders from the Department. The deed transfer of 312 11th Street is not known at this time. Morrison will check with the named buyer. The garage at 525 Jones has been removed and the owner continues to work on other details. The owner of the property at 216 Grover has not secured the property so another inspection will be scheduled by the DCD and review will be done by Council in August. An order of Demolition stands for 315 Main for July 27th unless a plan is submitted to DCD and Council for consideration. A property at 118 Hendricks Street has been readied for second inspection. A burned house on 204 First Street has been scheduled for inspection.

Introduced was Ordinance 2015-5, an amendment to the Subdivision Ordinance related to lot line adjustments when additional area is purchased to be added to an consensus, preliminary approval already existing lot. Consideration of adoption will be done at the next Regular Meeting.

from the American **Counseling Association** Each of us, regardless of age, forgets things. As teenagers we often "forgot" we were supposed to clean out the garage or be home by 11, though it usually bothered our parents more than it did us. But as we age we begin to notice that our memory may really be a little less sharp. That can be frightening, since we've all heard about Alzheimer's disease and early onset Alzheimer's, and may feel anxious that's our prob-

While Alzheimer's is a very serious disease, with no known cure or treatment, the fact that your memory sometimes is a bit hazy is not necessarily an indication of the illness. Today about 5.3 million Americans suffer from Alzheimer's and about 200,000 of

them experience early onset Alzheimer's (affecting someone under 65).

What most of us face is not Alzheimer's, but simply growing older. Experts tell us that some memory loss is a natural part of the aging process. While we all forget things now and then (like those stupid car keys), it usually is after age 70 that most people notice it may be happening more frequently.

Fortunately, there are things you can do to combat the natural memory loss of getting older.

One is to avoid smoking and heavy alcohol use. A Harvard Medical School study found that smokers perform much worse than non-smokers in memory and thinking skills test.

Experts also advise watching your diet. A diet rich in fruits and vegetables, but low in saturated fat and cholesterol, may improve brain health. They also suggest **ECO-FRIENDLY** that foods high in omega-3 fatty acids, like salmon and tuna, can help the brain.

Staying physically and mentally active will also fight memory loss. Physical exercise increases blood flow to the brain, which again means better brain health and function.

Exercising the brain itself also helps. An active social life is one way to do that. Activities like puzzles, reading, writing, playing games and using online "brain exercise" programs appear to stimulate brain cells and the connections between the cells.

You might also want a health check. Your drugs, cholesterol, blood pressure, or some diseases. can all play a role in memory loss.

If you're forgetting more frequently, find yourself repeating yourself in the same conversation, or being lost when faced with a familiar activity, it could be more serious. Talk to your doctor or a professional counselor for an evaluation.



Start by eliminating standing water in the yard. Buckets, old tires and clogged gutters and downspouts that hold water make the perfect breeding ground for mosquitoes.

Drain water that collects in these as well as kids' toys, tarps and pool covers. Store these items in the garage or turn them over to keep them from becoming a mosquito breeding ground. Even small containers hold enough water for hundreds to thousands of mosquitoes to breed.

Change the water in birdbaths at least once a week. Consider installing a small pump to keep water moving to prevent mosquito breeding. Or use an organic mosquito control like Mosquito Dunks and (SummitResponsibleSolutions.c om) in rain barrels and water features. The Mosquito Bits quickly knock down the mosquito larval population, while the Mosquito Dunks provide 30 days of control. They are both certified organic and safe for pets, fish, wildlife and children.

Wear light colored, loose fitting clothing. These pests are less attracted to the lighter colors and can't readily reach your skin through loose clothing. And be sure to cover as much of your skin as possible with long sleeves and pants.

Add a few birdhouses to the landscape to bring in the birds. You'll enjoy their beauty and benefit from their diet of insects, including many garden pests and mosquitoes.

Keep the garden weeded. Mosquitoes rest in shrubs, trees and weeds during the day. Removing weeds and managing neglected garden spaces will make your landscape less inviting to these

Consider using a personal repellent to protect you against disease-carrying mosquitoes. For those looking to avoid DEET, the Center for Disease Control and Prevention has also approved products with the active ingredient picaridin (found in Skin so Soft products), IR3535, and the synoil of lemon eucalyptus. Avoid products that contain both sunscreen and insect repellents as you need to apply the sunscreen more often than the repellent.

Add a bit more protection while sitting or eating outdoors. Use a fan to create a gentle breeze that keeps the weak flying mosquitoes away from you and your guests. fan into the garden, while weed-

Then add a bit of ambience to your next party by lighting a few citronella candles for your evening events. Citronella oil and the scented candles do have some mosquito repelling properties. Scatter lots of candles throughout your entertainment space. Position the candles within a few feet of your guests. This can provide some short term relief from these pests for you and your guests.
