We had rejections of \$80 in Food Stamps last month, so we'll try it again, but may have to accept only cash, money orders or checks. We'll see what happens. We know some don't get their food

stamps until after the deadline, so we're suggesting you make plans to budget that money ahead so you have enough that you can order the food. Again, ANYONE can order the Angel Food Menu and Specials. That menu has been publicized and is available everywhere. Call 375-2293 or 375-3022 if you need a menu. ### AREA NEWS

### GED ON TV

Can't pay nearly \$4.00 per gallon to drive to a GED class — try GED on TV at home.

Hoosier adults who couldn't complete high school may study from home with the GED Connection television series. The summer programs begin the week of June 22<sup>nd</sup>. In the shortened summer session, Indiana PBS stations and many cable systems will broadcast the reading, writing and math programs. Students will receive workbooks for reading, writing, math, science and social studies, but the science and social studies programs will not be on the television again until the fall semester. Strong readers can work through the science and social studies workbooks without the television programs.

The \$45 enrollment fee provides the student with a pre-test, three workbooks, a Casio fx-260 solar calculator, like the one they will be permitted to use for the first half of the GED math section, newsletters, the official GED Practice Test, and a Test Fee Voucher worth up to \$60 that will pay for the student's GED test at any local testing center in Indiana. Fifteen percent of all high school credentials issued in Indiana are GED diplomas. Nearly 8.000 Hoosier adults have earned a GED with GED on TV since 1990. Our students say that they like being able to learn from home because they do not have to have child care, they don't have to pay nearly \$4.00 per gallon for gas to drive to classes, and no one needs to know that they are preparing for the GED tests.

Adults who want or need to study at home for the GED test may enroll for the shortened summer semester now. A toll-free number, 1.877.433.6688, is available for enrolling from 8:00 a.m. until 4:00 p.m. Monday through Friday, and voice mail is available at all other times.

### COUNCIL NOTES

Due to Memorial Day, the Warren Town Council met on Tuesday evening, May 27. The meeting was held in Assembly Hall. President Bill Cartwright opened the meeting at 6:30 p.m. with all in attendance repeating the Pledge to the American Flag.

Council agreed to rezone 206 North Main Street from business to residential. They scheduled a meeting for May 30 to take final action on the Ordinance.

Curtis Day reported the downtown project continues on schedule. On Thursday they started pouring the new sidewalks.

An update was given on the Electric Tracker. There has been

an increase by about three cents per kilowatt. Customers should see an increase on their bills.

Council approved replacing some valves on waterlines. Three or four will be replaced every year.







Acute injuries, such as a sprain, strain, or fracture, happen suddenly: you may feel sudden pain, tenderness, swelling, or weakness. Chronic injuries stem from overuse overlong periods of
