#### SAMUEL JONES PIONEER IS ...

Following is the introduction read by Cynthia Smyth-Wartzok at this year's Samuel Jones Pioneer Award breakfast.

"It is that time of year again to honor an individual with the Samuel Jones Pioneer Award. As the purpose states this award goes to an individual who has unselfishly given of time, talent, resources, labor, skills and counsel for the overall betterment of the greater Warren Community.

Our current recipient was born at Andrews, Indiana. Married Wayne Herring in 1962, and at that time moved to Warren. She began a job at the Citizen's Telephone Corporation in 1962 and worked there until the office moved to its current location. During that time she started volunteering with the Salamonie Summer Festival. She was involved in many of the activities during the festivals, but mostly with the Art Show. Ruth Herring, would you please come forward and join me up front. After leaving the telephone office she started her own floral business in 1977, "Herring House of Flowers". At this time she also did some teaching in the adult education classes held at Huntington North High School. She had a successful business for several years, but was forced to close the doors in 1982 due to medical problems, which took its toll on her for several years. After surgeries were performed she was up and ready for a new challenge

In 2003 she agreed to set on the Warren Park Board, where she served at president for a year. Many projects that she has had a hand in were the walking path that goes around the Park, landscaping, tree planting and taking care of flowers planted outside in the Park area. In 2006 she handed her responsibilities over to the younger generation. During that time, she also took classes through Purdue University, and received her Master Gardner's Certification. She has done numerous volunteering jobs with Southern Wells School outdoor nature classes. She was able to lead the classes in landscaping projects, teaching how to properly care for their plants, and answer any questions that a fourth grade student might ask.

She is currently a part-time librarian at the Warren Public Library. In her many years of service at the library she has been involved in helping to organize the files on the history of the Town of Warren. She has also been involved in the restoration of the library and along with Jerry and Joan Boyer has done the landscaping around the library. A goal she has is to start up a genealogy area in the library and get more record books and more information on local families. She is also a member of The Friends of the Library, which provide materials for the summer reading programs and help out with on going activities at the library, such as story time.



#### RECEIVES AWARD

Parkview Huntington Hospital recently received a national 2007 VHA Leadership Award for Clinical Excellence in the category of Surgical Infections and Infection Prevention from VHA Inc., for its participation in a nationally recognized best practice standards for care for surgical patients. The award was presented in May during ceremonies at the VHA Leadership Conference in Denver.

Parkview Huntington participated in a Parkview Health Surgical Infection Prevention Performance Improvement Team in 2006, which helped support physician and staff education and assist in providing standardized care among all of the Parkview Health surgical suites. Overall, Parkview Huntington achieved a 92.3 percent compliance of the initial three best practice standards in 2006.

The three best practice standards implemented include ensuring that patients receive preventive antibiotics within one hour prior to surgery, that the antibiotics selected by the physician are recommended through research-based study and that postoperative antibiotics are discontinued within 24 hours after surgery. The surgery types normally

associated with the preventive initiatives include coronary bypass, cardiac surgery and vascular surgery. Parkview Huntington, however, has concentrated on the surgeries applicable to it, which include hip, knee and colon surgeries as well as hysterectomies.

"Our physicians and staff understand that prevention is the key to management of surgical infections," said Darlene Garrett, Parkview Huntington Chief Operating Officer. "The decision to standardize care procedures was essential to ensure that each patient receives the best care possible.

"Our surgeons, nursing staff, pharmacy staff and case managers are truly deserving of this recognition," she added. "Not only is this award evidence of their dedication to Parkview's mission to provide quality health services to all who entrust their care to us, but it is also an excellent illustration of how we carry out Parkview's Value of Quality, which is to put Trusted Care into action through technology, education and best practices in medicine," she said.



The hospital staff was able to track its progress using quarterly information reports, which helped motivate them to continually improve the process as their compliance rate soared from 73.7 percent in the first quarter of 2005 to 92 percent in the fourth quarter of 2006. Also, physicians updated their orders and order sets to include the best practice standards. Appropriate antibiotic selection rates improved from 68.4 percent in the first quarter of 2005 to 94.4 percent in the fourth quarter of 2006.

Parkview Huntington surgeons and physicians also worked with other professionals such as pharmacists, nurses and case managers to ensure that postoperative preventive antibiotics were discontinued within 24 hours following surgery. Improvements with this standard at Parkview Huntington Hospital have risen from 36.8 percent for the first quarter of 2005 to a high of 94.1 percent during the second quarter of 2006.
