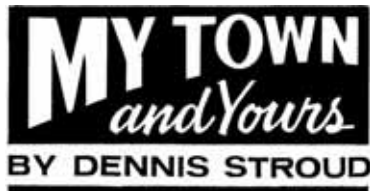
A TRASHY REMINDER

In 1933, across from the bank and west on Second Street, Dr. Black had his office in the brick house where Wayne Herring lives. Back towards Wayne Street, there used to be a building before you get to the Pulse Building; Harmon Chopson operated a small grocery. On the corner, in the Pulse Building, Dr. W. D. and Harold Bonifield had their offices and attached to the side was a small building where Frank Andrew had his pop corn and hamburger stand.

Walking south you would find Earl Smith's barber shop and

then Yarger's Bakery. Beside Yarger's was the Warren Tribune office with Monroe Wiley as owner. In the building next to the alley, Herschel Ruble had his radio and appliance store. Across the alley, in the old Odd Fellows building, was a meat market run by Ross Trusler and next door was Merritt Tam before he moved to the Sprowl Building. Upstairs, Dr. Laymon had his office and on the corner was Pearl Huff's Hat Shop. Next week, we will walk down First Street between Wayne and Main Streets. Last week I made a mistake. George and Ross Smethurst owned the hardware and V. U. Slater purchased it from George's wife in 1937. George was killed in the wreck at Kingsland.

She moved to Indiana at an early age and attended Tipton High School in Tipton, Indiana.



months, we urge those eligible donors with O negative blood type to make and keep appointments to give blood in the upcoming days to help restore the inventory level," Norris added.

"The Red Cross monitors the blood inventory on a daily basis and when we see a trend or shortage emerging, we communicate the need to our generous blood donors to help us make up the shortfall," said Norris.

Eligible volunteer blood donors are asked to please call 1-800-RED CROSS (1-800-733-

2767) or visit redcrossblood.org to find a blood drive and to make appointments.

A shortage of type O negative blood often occurs during the summer months when fewer donors are giving because of summer vacations and schools approaching summer break are hosting fewer drives.

Every two seconds, someone in the United States needs blood. The Red Cross Indiana-Ohio Blood Services Region provides lifesaving blood to 60 hospitals and must have 500 people give blood and platelets each weekday to meet hospital demand. Accident victims as

well as patients with cancer, sickle cell disease, blood disorders and other illnesses receive lifesaving transfusions every day. There is no substitute for blood and volunteer donors are the only source.

Individuals who are 17 years of age (16 with parental permission in some states), meet weight and height requirements (110 pounds or more, depending on their

height) and are in generally good health may be eligible to give blood. Please bring your Red Cross blood donor card or other form of positive ID when you come to donate.

4-H LIVESTOCK RULES

The Indiana State Board of Animal Health will not be requiring a "Certificate of Veterinary Inspection" for livestock shows this year. This policy was started in 2007 and will continue again this year. What this means for many 4-H exhibitors is that they will not have to have their local veterinarian look at the animals and write a (CVI) Certificate of Veterinary Inspection as was done for many years.

It will be up to the livestock exhibitors to carefully monitor their animals during the summer months to keep their health in order to exhibit at a fair where they could expose other animals. Most county fairs will still have a veterinarian at their livestock check in day to view the animals and look for any signs or symptoms of a contagious disease.

County fairs and their livestock shows are now required to record animal identification numbers for cattle, swine, sheep and goats. This is done in order locate various animals and exhibitors in the event of some type of livestock disease outbreak.

For more information about your counties livestock health requirements, contact the Indiana State Board of Health at 1-877-747-3038, your local 4-H Rule Book or veterinarian.
