## 4 STAR SCHOOL

**THE UPTOWN GARDENER**

Time is going so fast it is hard to believe that May is nearly gone, did we ever really have spring? I finally got some things planted in the small space I chose to have. Now keeping it watered is my past time activity. My garden this year consists of about a 4 foot row of green beans and a tomato and pepper plant, the rest of the area is in flowers some being perennials so I wont have to replant next year.

If my dad and mom could see "my garden" I would certainly get teased about it. I can just hear my dad saying "you better hire some help with all that". Any way I am enjoying the spinach and lettuce I planted in pots. Have had several nice sandwiches of peanut butter and lettuce with a few spinach leaves for extra flavor. Very nourishing even though one of my dear children think it is not her thing.

Our garden at home was large with rows 75-100 feet long and seem like it was endless, how I dreaded that job working and tending it often time it was just me tackling it. It was not unusual to pick 2 bushel of beans in one picking then getting them ready for canning. The other half of the garden was in all potatoes, that spot was at one time where the old barn sat and the soil was rich and loamy. Dad sold several bushels of potatoes to people in town and guess who had to help harvesting them, but I enjoyed being with my dad more than being in the house learning domestic chores which I feel I had my share of them to do also. So now I should be thankful for the easier life I now have and enjoy my 4 foot row of beans and the lonely tomato and pepper plant.

With all the vegetables we had mom made the basement really fill up with good stuff for the winter months and until the garden came on again. One thing she made up was tomato soup which I found in her old cook book and it always tasted good on a cold wintery day.

It took 1 peck of tomatoes or about 20 pounds, 2 onions, 1/2 cup salt, 1 stalk of celery, 3/4 cup brown sugar, 1 cup flour, 1/2 teaspoon allspice, 1/2 teaspoon cinnamon, 1/2 teaspoon pepper, 1 teaspoon chili powder, 1/2 cup butter. Cut and chop up all the vegetables, put in a large soup pot or 2 containers and bring to boil and simmer about 1 hour or until vegetables are tender. Put mixture thru a food mill (I use a blender). Transfer to a large container and add all the rest of ingredients except the butter stirring in gradually when blended add the butter and simmer till butter is melted. Pour into hot jars, seal and process in hot water bath for 15 minutes counting the time when the water starts to boil.

I process this in pint jars and when serving add a can of cream mushroom soup and top with French dried onions. Mom always served it with milk added to make cream tomato soup. Have a great summer

An entry fee of \$15 (per specie) must accompany the entry. A fee of \$50 must accompany entries postmarked June 2- July 31. Only hand delivered entries will be accepted from August 1 until check-in time and must be accompanied by a \$50 late fee plus an additional fee of \$50 per animal.

The July 1st entry deadline remains the same for 4-H Alpacas, Boar Goats, Dairy Goats, Meat Goats, Dogs, Cat, Horse & Pony, Llamas, Pigeons, Pygmy Goats, Poultry, Rabbits, and Waterfowl.

Entry forms may also be obtained at the Wells County Office of the Purdue Cooperative Extension Service located at the 4-H Park in Bluffton, telephone number 260-824-6412. Office hours are 8 A.M. to 4:30 P.M. Monday through Friday.

Ordinance 2013-2, amending wastewater rates, was introduced and a hearing is set for June 10 at 6:30 p.m. The increase has been set at 8%. A user of 4000 gallons of water would have an increase of \$3.34 per month.

Council had been advised by Ben Adams of Commonwealth Engineering, that plans and estimated costs for the construction of the cul-de-sac at the end of Winterhaven Drive in Langton Estates, so that development can continue in the area, would be submitted by May 15.

Representing Warren Area Chamber of Commerce, Ethan Stivers reported that Business Expo, held at Salamonie School, had thirty vendors. Also it was reported that proceeds from the recent Wine Tasting will be used to develop the Chamber Park Area on First Street.

Acting Utility Manager Poulson said the permit had been received for INDOT. This is for necessary electric work at the replacement of a culvert on State Road 5. The culvert is being replaced by INDOT. Deadline for the work is August 1.

### HOOK RESTRICTIONS RELAXED

Anglers can affix up to three hooks, three artificial lures, or a combination of hooks or lures not to exceed three per pole under a temporary rule that takes effect May 24.

The long-standing permanent rule allowed just two hooks per pole. Other changes in the temporary rule define "artificial lure," "bait," "fly," "hook," "pole" and "line."

"These changes were needed to clarify Indiana's fishing regulations so that everyone can more easily determine what fishing tackle can be used," said DNR director Cameron Clark. "New devices are always coming onto the market and in the past, it has not always been clear if they were permissible."

Under the new rule, an umbrella rig, for example, now can have up to three hooks and unlimited hookless attractors. When artificial lures are used on an umbrella rig or similar device, they are considered one hook, even if the lure has multiple hooks.

Under the old permanent rule, it was uncertain how many hooks could be used on umbrella rigs. A temporary rule that allowed five hooks on umbrella rigs expired last December after a one-year trial.

As in the past, anglers are still allowed to fish with up to three fishing poles or lines at a time.

become familiar with Indiana boating laws and follow safe boating procedures by following these tips:

1. Always wear a life jacket.
2. Never sit on the gunwale (side) of a motorboat while in motion.
3. Do not ride on the bow decking of a motorboat while in motion.
4. Never tow a skier or tuber without an observer.
5. Pay attention to marker buoys and idle zone restricted areas.
6. If 21 or older, only consume alcoholic beverages in moderation (0.08 is the legal limit).
7. Use navigational lights and anchor lights between sunset and sunrise.
8. Nighttime speed limit is 10 MPH on all inland lakes.
