Mature American Citizens.

But, says AMAC, it ain't necessarily so. In fact, the Food and Drug Administration agrees with the Consumer Reports study.

Rhonda Kane, a registered dietitian and consumer safety officer at FDA, says that "eating gluten-free is not meant to be a diet craze. It's a medical necessity for those who have celiac disease."

"There are no nutritional advantages for a person not sensitive to gluten to be on a gluten-free diet," she adds.

"The Truth About Gluten," the Consumer Reports research document, is available on its Web site and in the January 2015 edition of its magazine, which is available on newsstands.

PLANNING FOR RETIREMENT HEALTH CARE

A new report published by Ameriprise Financial shows that retirees will need an average of about \$230,000 per household for their old age, according to the Association of Mature American Citizens.

However, Pat O'Connell, executive vice president, Ameriprise Financial, notes that "Boomers understand that health care costs will be a significant expense in retirement, yet many haven't planned - or simply don't know how to plan - to fund these expenses."

Those living in Russia, Eastern Europe, Latin America and other non-English-speaking regions apparently grow less satisfied with their lives as they age.

AMAC says it has a lot to do with contrasting economic conditions and healthy lifestyles that exist as well as the social disruptions that have occurred in many parts of the world.

"Family engagement is a vital part of each child's education. On behalf of the Indiana Department of Education, I want to first and foremost say, 'Thank you' because you are your child's first teacher.

"As a classroom teacher of 34 years, I know that it takes a partnership between families and educators to ensure our children are healthy, safe, and engaged in learning. I travel 2 to 3 days per week around Indiana visiting our schools, and I can see evidence of family engagement in our schools.

"The mission at the Department of Education is to build an education system of equity and high quality, focused on student-centered accountability. To achieve this mission, family engagement is paramount. Great family engagement happens at the school level, but occasionally, there is a need to contact the Department of Education.

"The Department of Education also has in place our Outreach for School Improvement team, with 13 Outreach coordinators throughout Indiana working with schools at the grassroots level. Our Outreach coordinators want to partner with our Parent/

Teacher association and organization leaders to increase family engagement. Please visit the Department's website where you will find the contact information of the Outreach Coordinator in your area.

"Stay tuned for upcoming quarterly communications. My next family engagement message will focus on the 2014-15 state ISTEP test. In the meantime, you might be interested in viewing my three-part video series entitled The State of the Classroom. This series of videos is meant to spark a conversation about education in Indiana.

"Enjoy the fall season with your children! Thank you for making sure they are ready to learn each day with the food, exercise and sleep their bodies and minds need to be alert. Thank you for supporting their educational studies at school and making sure they are reading at least 20 minutes five days per week at home. Reading is fundamental to being a lifelong learner. As an educator, I promote reading as one of the best family engagement activities to ensure success for our students."
