### WEST NILE INFO

INDIANAPOLIS—State health officials today announced 21 additional probable human cases of West Nile virus, bringing to 79 the total number of probable or confirmed human cases in Indiana.

The ages of the probable cases announced today range from 43 to 80 years of age.

Counties that have their first probable human cases, and the number of those cases, are: Adams County (1), Grant County (2), St. Joseph County (1), and Vanderburgh County (1).

Counties with new cases, and the total number of probable human cases in those counties, are: Allen County (2), 25 total; Elkhart County (1), 2 total; Gibson County (1), 7 total; Lake County (8), 14 total; Madison County (1), 3 total; and Marion County (3), 10 total.

These cases have tested presumptively positive in two separate tests at the State Laboratories. The specimens have been sent for confirmation testing to the laboratory at the Centers for Disease Control and Prevention (CDC). Confirmation from the CDC is still pending on other probable Indiana cases.

State health officials say that September and October are particularly dangerous months for West Nile disease and urge individuals to continue to take the following precautions:

- Use an insect repellent that contains DEET. Look for N,N-diethyl-m-toluamide or, sometimes, N,N-diethyl-3-methylbenzamide.
- Wear shoes, socks, long pants, and long sleeves when outdoors

for extended periods of time or from dusk to dawn, when mosquitoes are most active.

· Eliminate areas of standing water available for mosquito breeding in or near your property, including old tires, cans, plastic containers, ceramic pots, or other unused containers that can hold water.

- Repair failed septic systems.
- Clean clogged roof gutters, particularly if leaves tend to plug up the drains.
- Aerate ornamental pools, or stocking them with predatory fish. West Nile virus can only be transmitted to a human by a mosquito that has first bitten an infected bird. A person who is bitten by an infected mosquito may show

### DEAR EDITOR OF THE WARREN WEEKLY,

I am sending a copy of my resignation letter, for the Youth Services Bureau of Huntington County, to the paper so people know why I am resigning. It is my objective to disseminate as much information about ADHD and Dyslexia to the people in and around Huntington County, with the hope that other children who are struggling, from no fault of their own, can get assistance to help them reach their potential! Here is my letter.

As a board member of the Youth Service Bureau I always felt like my focus was to be an advocate for the Youth in the community. But now my focus has taken a much more narrow concentration.

Most of you know that Greg & I have 5 children (They are wonderful!). In October of last year our youngest son, was diagnosed with ADHD inattentive type. He started on medication that helped dramatically. His diagnosis led us to seek a diagnosis for our oldest son who is a senior at Purdue. We felt that we had found the answer to some puzzling question (I have also been diagnosed).

Both sons continued to struggle, so there were still questions that eluded an answer. Purely by accident I heard an announcement on the radio about the Scottish Rite Learning Center, in Ft Wayne, that provided tutoring for free, so I called regarding our youngest. They said that he must be diagnosed with dyslexia before he could be added to the 1-1/2 year waiting list. We had him tested. He was diagnosed as having moderate to severe dyslexia. Our oldest is now in the process of being tested for dyslexia. He would have his BS in Computer Science except for his foreign language requirement (we will be seeking a waiver for the foreign language requirement, foreign language is almost impossible for a dyslexic to learn).

It is with regret that I feel I must resign from the board. If I am not an advocate for my sons they will fall through the cracks (they already have). I will be working on remedial dyslexia training until he can be accepted into the program at the Scottish Rite. I also plan on becoming very vocal to the school board, superintendent, teachers, parents, and anyone who will listen and to some who will not.

symptoms from 3 to 15 days after the bite.

Most people who get infected with West Nile virus will have either no symptoms or mild symptoms. A few individuals will have a more severe form of the disease, encephalitis (inflammation of the brain) or meningitis (inflammation of the tissues that cover the brain and spinal cord).

You should see a doctor immediately if you develop symptoms like these:

- high fever,
- severe headache,
- neck stiffness,
- muscle weakness or paralysis,
- nausea, vomiting,
- sore joints, or
- confusion.

Culex mosquitoes, which carry the West Nile virus, breed in places like ditches, open septic systems, discarded tires, unused wading pools, and other assorted containers, particularly if they are in the shade. A small bucket that has stagnant water in it for seven days can become home to up to 1,000 mosquitoes.

Even though Culex mosquitoes only bite humans on occasion, state health officials warn that there are large numbers of these mosquitoes across the state and that a high percentage of them are testing positive for West Nile virus.

## COUNCIL NOTES

Council approved minutes of the regular meeting on Aug. 26.

The Park Board met prior to the Council meeting. David Scheib reported the Board will look at the Town Code Book concerning Tower Park for any additional corrections. Rules for the newly paved walkway at the Park will be the same as for downtown sidewalks in regard to skate boards, in-line skates and bicycles. The

next meeting will be Oct. 14.

Council is asked to join the Park Board for the Fall Walk Through at the Park, set for Saturday, Sept. 28 at 9 a.m.

Greg Guerrettaz reported there are no major updates on the Business Plan.

In a progress report of the Wastewater Project it was indicated the Engineer had submitted plans for inspection of the Project. Council accepted the change.

Resident Inspection was approved as sent by Engineers.

Sept. 24 will be the closing date for Rural Development Financing. This will be held in Town Hall Annex. Jackie Huffman was authorized to execute documents if President Jones is unable to be present.

Resolution 7-2002 was adopted, a resolution officially accepting a grant of \$1,280,000 and a loan of \$2,720,000 from USDA-Rural Development.

In regard to 2003 Municipal Budget, Resolution 5-2002 was adopted. This allows reducing reduction of appropriations within the 2002 Municipal Budget.

Council also adopted Ordinance 2002-11, 2003 Municipal Budget.

Resolution 6-2002 was introduced. Council will vote later, setting tax rate for 2003 Municipal Budget.

Landscaping at the Water Treatment Plant is to be completed by Ben Herr, hired by Brudney Construction to complete the project.

Council denied an invoice change order for Grover Street, Tower Park drive paving. The invoice was rejected because the job had not been completed as bid.

Spectrum Engineering joint use and pole attachment policies are to be taken under advisement. Copies have also been submitted to Citizens Phone and Cable.

State Board of Accounts Exit Interview was held on Sept. 4. The audit findings showed a very good audit.

In a draft copy of Personnel Policy, a number had been made in wording. Council took under advisement giving time to review changes.

Distribution of recycling blue bins is expected to begin as soon as letters are printed to be sent in each bin by the Huntington County Solid Waste District. Leftover blue bags can be used for trash bags after the bins have been distributed as long as they are not used on recycling days.

Council voted to put up flags for Sept. 11.

Ordinance 2002-15, 16, 17 was introduced in regard to Salary Ordinances and reflect a \$500 increase per employee plus \$500 additional toward retirement.

Marilyn Morrison and Janet Richison are expected to attend the annual Keystone training for software updates.

Indiana Rural Water Association membership dues of \$140 were paid.

Annual membership dues of \$1700 was authorized for HCUEd. Clerk-Treasurer Marilyn Morrison gave the August Financial report.

Darrel Bice gave the Utility/Street Departments report. Projects included: continuing the meter installation project; repair of waterline on Fifth Street; burying lines at Tower Park; work on playground equipment at Tower Park.

Bice was authorized to check for another pole truck.

The IMEA Fall conference will be Oct. 1-3 in Indianapolis. Larry Poulson and Darrel Bice are expected to attend.

Fire Chief Tim Ford gave the August report for the Fire Department.

Work had begun on installation of new communications equipment.
