## DESALVO AT HERITAGE POINTE

Jodie DeSalvo has captured national and international acclaim from her dynamic interpretations of the classical masters. With her superb technique and musical mastery, she has the communicative powers and exuberant energy to captivate her audience through an exciting musical journey. She graduated from the Hartt and Manhattan Schools of Music as a student of such noted teachers as John Browning, Gary Graffman, Jascha Zayde and Nina Svetlanova.

Upon winning the Artist International Competition in 1988, DeSalvo made her Carnegie Hall debut to critical acclaim with an encore performance two years later at Lincoln Center. She has been a top prize winner in the Young Keyboard Artists Association, the American Music Scholarship competition and the National Federation of Music Clubs competition. She is a past recipient of the Artist Fellowship Grant from the National Endowment for the Arts.

She has toured extensively in North America and Europe as soloist with the orchestras of Chicago, Geneva, San Francisco and Hartford under the batons of David Effron, Gisele Ben Dor, Paul Freeman, and Christopher Wilkins.

DeSalvo has appeared numerous times with the Fort Wayne Philharmonic under Maestro Edward Tchivzhel. She has performed chamber works with cellist Sharon Robinson, cellist Keith Robinson, the Miami String Quartet, flutist Christine Nield, the Bergonzi String Quartet and Naples Philharmonic Orchestra concertmaster, Glenn Basham. She appeared in Chamber 2 last season at the Philharmonic Center, performing in Brahms' Piano Quintet in F Minor and in Pops 1, in Gershwin's Piano Concerto.

DeSalvo has played at such prestigious festivals as Chautauqua, Brevard and Birch Creek in Door County, Wis., as well as over 100 times on National Public Radio.

An artist faculty member at Florida International University in Miami, DeSalvo continues to perform extensively internationally. She has recorded six CDs of solo and two-piano music. DeSalvo is director of choirs and artistic director of concerts at the Community School of Naples.

She will be performing at Heritage Point on June 15 at 2 p.m. in the Applegate Chapel. Everyone is invited to come listen to this lovely artists performance.

## BOATING PERMITS

Before you take your crew on a boating trip this season, make sure you have purchased the required lake permit for state-owned lakes.

As of last year, boaters can no longer purchase a daily launch permit at the entrance gate or ramp as they enter a state property. Instead, they must buy an annual permit, which allows them to use any state park, reservoir or state forest lake in the state for an entire year. Cost is \$20 for motorized watercraft, \$5 for non-motorized watercraft.

This permit system saves staff costs, and should also allow boaters quicker access to the water. Funds from the lake permit go to a dedicated account, along with camping, entrance, swimming and program fees. Those funds support the operations of state parks, reservoirs and state forests.

"These permits are available at state park, reservoir and some state forest offices, online at Mother Nature's Mercantile (<http://estore.dnr.state.in.us/>), and at entrance gates during regular property business hours," said Dan

Bortner, director of State Parks and Reservoirs, who pointed out that the permits should be purchased before taking a boat on the water.

Bortner said that conservation officers will be on the lookout for those without permits. Owners without them may be fined.

All private watercraft using state park, reservoir or state forest lakes must display a current permit. This includes personal watercraft, motorboats, canoes, paddleboats, rowboats and all watercraft moored at marinas, private docks, group docks or bank ties. Only state-owned watercraft and state-managed boat rental concessions are exempt.

The permit should be placed on any boat that will be on the water at Indiana state parks, state-managed reservoirs or state forests. This includes the main bodies of water and all fishing ponds/lakes at these lakes: Patoka, Brookville, Hardy, Monroe, Salamonie, Mississinewa, Roush (Huntington), Cagles Mill (Lieber) and Cecil M. Harden (Raccoon).

It also includes Worster Lake at **CONTINUED PAGE 4**

Potato Creek State Park; Kunkel Lake at Ouabache State Park; Summit Lake at Summit Lake State Park; Versailles Lake at Versailles State Park; Ogle and Strahl Lakes at Brown County State Park; Lakes Shakamak, Lenape and Kickapoo at Shakamak State Park; all lakes at Chain O'Lakes State Park; Spring Mill Lake at Spring Mill State Park; Whitewater Lake at Whitewater State Park; and Lake Lincoln and Weber Lake at Lincoln State Park.

All lakes at state forest properties are also included: Deam Lake SRA, Ferdinand State Forest, Starve Hollow SRA, Harrison-Crawford State Forest, Clark State Forest, Greene-Sullivan State Forest, Jackson-Washington State Forest, Martin State Forest, Morgan-Monroe State Forest, Owen-Putnam State Forest, Pike State Forest and Yellowwood State Forest.

There are a several locations around the state with public access sites maintained by the Division of Fish and Wildlife (DFW) where this permit is not needed. Those who plan to boat only in these locations and not in any of the locations listed above do not need a lake permit.

The permit also is not required for boating on Indiana streams and rivers, nor is it required on natural lakes, such as Lake James, Lake Wawasee and Lake Michigan. Lakes located in state fish and wildlife areas that are operated by the DFW do not require this permit. Lakes at national forests and U.S. Fish and Wildlife refuges also do not require this permit.

The lake permit differs from the Lake and River Enhancement (LARE) Fee that is charged when boaters register a watercraft with the Indiana Bureau of Motor Vehicles. The LARE fee and the lake permit are entirely different programs. Funds from the LARE program are administered by the DFW. The program's purpose is to ensure the continued viability of Indiana's publicly accessible lakes, streams and reservoirs by controlling inflows of eroded soil and associated nutrients to lakes, streams, and reservoirs.

### RESOURCE GUIDE

### LIVESTOCK CHANGES

The Indiana State Board of Animal Health has discontinued the requirement of a "Certificate of Veterinary Inspection" for 2007.

What this means for many 4-H exhibitors is that they will not have to have their local veterinarian look at the animal and write a (CVI) Certificate of Veterinary Inspection as was done for many years.

It will be up to the livestock exhibitors to carefully monitor their animals during the summer months to keep their health in order to exhibit at a fair where they could expose other animals.

Most county fairs will still have a veterinarian at their livestock check in day to view the animals and look

for any signs or symptoms of a contagious disease.

County fairs and other livestock shows are now required to record animal identification numbers for cattle, swine, sheep, and goats. This is done in order to locate various animals and exhibitors in the event of some type of livestock disease outbreak.

Apre-1840 encampment and Living History Weekend Rendezvous will be held Ouabache State Park, June 15-17.

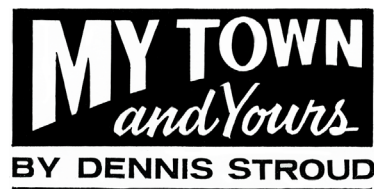

At the turn of the century, investors were betting on the future of the electric railways against the future of the infant automobile industrial. Overnight, the Warren community went from agricultural to becoming industrialized. The gas and oil boom began in 1888 and lasted for about twenty years. Warren's population climbed from 358 in 1870 to 3,152 in 1900. The railroad was dedicated to the long haul freight business and could not satisfy local transportation requirements. In June 1905, the Marion Bluffton and Eastern began laying tracks and on December 15, 1906 the line was in operation.

The MB and E was construction by the Moore-Mansfield construction company. Warren was about the halfway point. The length of the line was 31.5 miles. Between Warren and Bluffton, the land was mostly flat, so there were few grading and construction problems. The bridge over rock creek, just north of Liberty Center, was the greatest construction feature. Between Warren and Marion there were two

major rivers, the Salamonie and the Mississinewa, and some gently rolling land that required a little more work.

The track was standard gauge four feet eight and a half inch wide made up of seventy pound rail. Most of the track was hastily constructed and after two years, new ties and reballasting was required. Five passenger-baggage cars and one express-baggage motor car was ordered. More about the interurban cars next time.
