OFFICE CLOSED

(Editors Note: This information was received late but is still relevant for the most part.)

County Treasurer's Office will be closed beginning Monday, April 10, 2006 for printing, folding, and stuffing tax bills for mailing, hopefully, around the middle of April. The deadline will still be May 10th. State Legislators passed a bill on March 14, 2006 that raised the homestead credit to 28%. Those with a homestead exemption should see a decrease in their taxes. This caused a delay in getting out tax bills any earlier.

Our office should remain closed for approximately one week. Getting your tax bills out is our first priority. If you have business other than property taxes, please knock on our door and we will be glad to assist you. When we reopen, our hours are 8 a.m. to 4:30 p.m. Monday thru Friday. We are open the last Saturday morning before the deadline and this season will be May 6, 2006. Hours will be 8 a.m. until noon.

Huntington County has also converted to 18 digit parcel numbers this year. This is to enable the State offices to pull up on maps any parcel in a particular County by Township and Range with uniformity in all 92 counties. All of Huntington County parcels will begin with 35 just like our license plates. The last three numbers is the district you are in (ie. Clear Creek, Dallas, etc.) Our taxing district numbers have also changed in some districts to what the State used for those districts. Huntington Corporation use to be 014, it is now 005. If you use the parcel numbers to keep track of your property, the

old parcel number will appear in the legal description box on the tax bill.

The longest month of the year for me has finally passed. March is an unsettling time were winter often does not want to end. I welcome April knowing spring can't be to far away. Actually March is a good time to really think about some serious planning of the garden and flower beds.

Really I'm ready for spring soon as I take down the Christmas tree and start getting those seed catalogs.

Each year I try a new veggie in our small "uptown garden". Last year I planted acorn squash a favorite vegetable of ours. Thinking I had bought the bush variety—WRONG! Had I not kept the vines trimmed back they would have found their way right down Second Street to the village square. They grew very well and fast! The acorn was very tasty and enjoyed some all winter that I had frozen. New for us this year will be Kohlrabi and garlic bulbs and I do have the bush variety of acorn squash.

It amazes me how much you can get from a small garden, I plant the rows close and sometimes I think I have grown a jungle. I can remember my mother every summer if she didn't have at least 500 jars of food put away in the basement we would have had a serious food problem for the winter.

Gardening can be a great exercise and a time I look forward to just being outside.

Hopefully this year I might have extra produce to take to the Farmers Market. Last year the market was a great success and the Sunflower Co-op is looking forward to a even better year.

Here is a recipe that is great for a garden salad. It is a variation of the one that was served in the tea room of Wolfe and Dessauer years ago.

Vinegar and Oil Dressing

| 1 cup of oil | 1 cup white vinegar |
| 1 ¼ cup sugar | ½ tablespoon white pepper |
| 1 finely chopped onion | ½ cup chopped green pepper |
| | ½ cup chopped pimento or red pepper. |

Put the oil, vinegar, sugar, onion and white pepper in blender and blend well. Add the green peppers and pimento. Refrigerate several hours before serving.

LOOK OUT FOR FARMERS

Temperatures are rising, grass is growing and birds are chirping: the signs of spring in Indiana are more apparent every day. But another sign of spring - farmers taking machinery to their fields - requires extra awareness from everyone on the road.

"Farmers are on the roads because they are trying to get to their place of work, just as motorists are trying to get to their place of employment," said Carolyn Hegel, Indiana Farm Bureau 2nd vice president. "The days of a farm family just working on their homestead acres are long gone. Some farmers must travel many miles to get to their fields."

According to the Purdue University Agricultural Safety and Health Program, 25 percent of farm-work related fatalities were a result of roadway collisions in 2004. One of the main causes is motorists not taking into account the difference in speed between their vehicle and farm machinery. For example, if a car is traveling 55 miles an hour and comes upon a tractor moving 15 miles an hour, it only takes five seconds to close a 100-yard gap between the car and the tractor.

"When motorists see a slow-moving vehicle sign or flashing lights, they need to slow down," said Hegel. "Farm machinery can be very wide. Motorists should follow behind until there is a safe place to pass."

Hegel also suggests farmers take precautions before traveling on the road, such as checking the condition and placement of slow-moving vehicle signs and lights. Avoiding busy roads, using hand signals to indicate turns and traveling only in the daytime are also good strategies.

Ultimately, exercising common courtesy and common sense are the best ways to travel safely during planting season.

"Safety is everyone's responsibility," said Hegel. "It doesn't

matter if you are right if you are injured badly or killed."

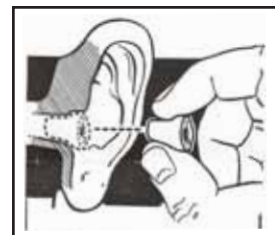

Asthmatic Children Get Opportunity to Attend Summer Camp
