KUDOS, KICKS & KARATS

THE UPTOWN GARDENER by Ruth Herring

What wonderful weather we have had, this could last for ever although I would like to see snow on Christmas day and then get nice again.

The frost warnings we had few days back I got to thinking it is time to get some things under cover. So I have managed to get some clippings started for next year. (Not to be rushing the seasons) Some of the geraniums are so large I am not sure I can bring them in. I will leave them out till the very last and decide what to do with them.

I have a mum plant that my friend gave me a start of and was just a tiny sliver two years ago now it is quite large. It blooms very late and the frost seems not to bother it. I even cut some blossoms to bring in after a hard freeze. When it blooms it is a mass of soft pink daisy like blooms. This year there is surely hundreds of blooms on the plant.

This week I hope to get some windows washed on the outside, but for sure it won't be all 50 plus of them. Doc Black must have thought all those windows letting in good light would save on electricity. Also got some winterizing to get done while it is nice out.

I can remember my mom getting the house ready for winter. I was a good cleaner from top to bottom. We took up the rugs and had the rug beater going after them, we hung them over the clothes line to do this and afterward laid the rugs out on the grass and sprinkled salt and soda mixed together then swept them with a broom.

They did smell fresh and clean when we brought them in. Before laying the rugs we put down many layers of news paper to help keep the floor warmer. Not really sure if it helped but we hoped it did. We also had to clean all the walls down with the wall paper cleaner and wash and polish everything in the rooms. Then came the time to bring in the ole heating stove, lucky dad always cleaned the chimney before we started all this. The house always smelled fresh and clean after all the hard work.

You could plan on a big ole pot of vegetable soup on cooking during this time, and it sure tasted good. With it was most often a Dutch apple pie for dessert. I found her recipe for it and will pass it on.

1 unbaked crust for a 9 inch pie, enough apples to fill the crust (we always went to the woods to gather the apples.) Sprinkle over the apples a mix of 3/4 cup sugar bit more for tart apples. 1 teaspoon cinnamon, 1/8 teaspoon allspice, 1 tablespoon cornstarch mixing well to coat the apples. Place apples into the pie shell Then slice thin about a teaspoon butter place it on the apple- sugar mix. She then added about 3 tablespoons pure cows cream drizzling it over the apples. Make a crumb topping of 1/2 cup flour 1/3 cup sugar and 1/3 cup butter. Mix together till finely mixed and sprinkle over apples. Bake 350 for about 45 minutes.

It was good stuff! Have a great autumn

"A fresh look at your financial situation can give you new

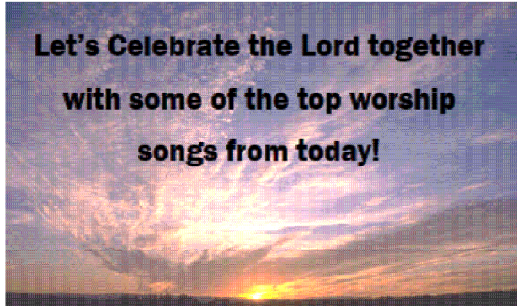

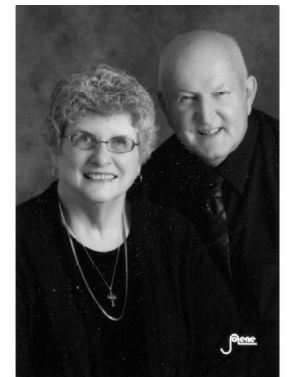

Twenty-seven members and two guests were present for the first meeting of the 2011/2012 year of the Chautauqua Literary Club. President Barbara Engle welcomed everyone, and described the theme of the year—"Stand Up For America!" She gave a moving word picture of the history and philosophy of our Country.

Following the business meeting, Nancy Bonham introduced her daughter, Vivian Blakeslee, who presented the afternoon's program primarily about ASD—or Autism Spectrum Disorders. Vivian has worked previously with First Steps, and is now the ADEC Program Manager of Elkhart County. ADEC 's mission is ---"open hearts, open minds, and open doors." It needs to be remembered that each individual with Autism is unique and may act differently than others. When you know one person with Autism, you know one person with Autism! There are no patterns or remedies that fit all people.

Often when people with

Autism can't figure something out, they are ridiculed or punished for it. The pattern for many with Autism: What activity comes next, and what am I supposed to do in it?

Points to note:

ASD's are a group of developmental disabilities caused by a problem with the brain. It is NOT mental illness.

They may communicate, interact, behave, and learn in ways different from other people.

You will be about 4 times as likely to see a male with ASD than a female.

The spectrum varies from mild to very involved, from very verbal to completely non-verbal.

GOAL---reduce confusion and frustration.

HELPFUL HINTS: Speak Slowly and use simple language: Use concrete terms: Allow time for responses: Give lots of Praise: DO NOT attempt to physically block self-stimulating behavior: Explain each step before taking action: Use pictures and symbols as much as possible.

RED FLAGS FOR AUTISM--- No big smiles by 6 months: no back and forth sharing sounds, smiles, or other facial expressions by 9 months: no babbling by 12 months; no back and forth gestures like pointing, showing, reaching, or waving by 12 months; no words by 16 months; no 2-word meaningful phrases by 24 months; any loss of speech, babbling, or social skills at any age.

Ask for a developmental evaluation from your doctor as soon as you notice any of these markers. EARLY INTERVENTION IS VERY IMPORTANT!!!!!!

There are many excellent resources available in libraries to learn more about Autism. Walk Awhile. McGinnity, Kate, and Negri, Nan. Cambridge

Book Review Press, 2005. Many interesting questions and comments were forthcoming.

WHAT TO KNOW WHEN DEALING WITH A DEPRESSED PERSON

If someone you love has spoken about committing suicide don't lecture them about the immorality of it. They have already thought about that themselves. Love them, support them, the last thing they need is argument.

Know that you can rightly assure them that most people get over their depression within six months or less. This way they can hang in there knowing that most likely it will go away.

Certainly don't act shocked, even if you are. That can break whatever bond you have in a matter of minutes. And, yes, ask them if they are thinking of killing themselves. You won't be planting a seed. You will quite likely be defusing a bomb.

Depression knocks on the door of too many older Americans. It is not that circumstances do

not feed this disease; loss of a loved one, illness or an unwillingness to be a burden to family. Whatever is the reason those who have experienced it say it weighs a thousand pounds.

There are things that need to be realized by both the depressed and those who know and love them. First, if you are depressed, don't feel stigmatized by the feeling. Indeed, welcome aboard the human race. Then having admitted you are being overwhelmed talk with someone, your pastor or someone at a mental health center. You may well be advised to take an anti depressant. Certainly don't try to muscle it through on your own.

WATERFOWL SEASON

Dust off the calls and decoys, Indiana's waterfowl hunting season begins Saturday, Oct. 15 in the North Zone; Oct. 22 in the South Zone; and Oct. 29 in the Ohio River Zone.

Waterfowl hunting season in Indiana is divided into three zones: North, South and Ohio River. Each zone has different a season for ducks and Canada geese. Light (snow/Ross) geese, brant and white-fronted geese are regulated statewide.

The North zone is defined as that part of Indiana north of a line extending east from the Illinois border along Indiana 18 to U.S. 31; north along U.S. 31 to U.S. 24; east on U.S. 24 to Huntington; and southeast on U.S. 224 to the Ohio border.

The South Zone is that portion of the state south of the North zone boundary and north of the Ohio River zone.

The Ohio River zone is that portion of the state south of a line extending east from the Illinois border along Interstate 64 to New Albany; east on Indiana 62 to Indiana 56; east on Indiana 56 to Vevay; along Indiana 156 along the Ohio River to North Landing; north on Indiana 56 to U.S. 50; and northeast on U.S. 50 to the Ohio border.

The daily bag limit for ducks is six. This includes any combination of goldeneyes,

ruddy ducks, ring-necked ducks, buffleheads, gadwalls, long-tailed ducks, scoters, teal, wigeon and shovelers. There are additional bag limit restrictions on numerous duck species. Review these restrictions online at <http://www.in.gov/dnr/fishwild/3569.htm>. The possession limit for Canada geese, white-fronted geese and brant is two times the daily limit. There is no possession limit for light geese.

The youth waterfowl seasons are also zone specific. The North zone youth waterfowl season is Oct. 8-9, South zone youth waterfowl season is Oct. 15-16, and Ohio River zone youth waterfowl season is Oct. 22-23. The youth seasons are open to hunters 15 years of age or younger. To participate, youths must be accompanied by an adult at least 18 years of age. An adult may accompany more than one youth. The licensed accompanying adult may hunt only snow geese, brants, and whitefronted geese (if those species are in season). If the accompanying adult does not intend to hunt and does not possess a firearm, the adult does not need to be licensed. Bag and species limits are the same as those allowed in the regular season.

A hunter must possess a hunting license, resident youth consolidated hunting license, or disabled American veteran's hunting license, in addition to a state waterfowl stamp privilege and HIP registration number. Any hunter 16 years or older must have a signed federal duck stamp when hunting ducks and geese. Those that possess valid lifetime hunting or lifetime comprehensive hunting licenses do not need the Indiana waterfowl stamp; however, they still need to have a HIP registration number and a federal duck stamp if 16 years old or older. Resident landowners or lessees, hunting on farmland they own or lease, are exempt from the state license requirement except that a federal duck stamp and HIP registration are still required.
